



COUPON CODE REDEMPTION

The notice attached to your settlement check states your Asiana and Korean Air Coupon Codes and amounts. This letter from Chicago Clearing Corporation (CCC), the court-appointed Coupon Administrator and market maker, explains how to use your Coupon Codes, acquire more Coupon Codes or sell your Coupon Codes for cash value.

DO NOT lose your Coupon Codes and flight ticket numbers; you will need them to redeem the coupons.

You can use Coupon Codes toward reimbursement on a portion of or the entire purchase price of a flight purchased from Korean Air (KE) or Asiana Airlines (OZ).

KE Coupon Codes can be used on eligible passenger flight tickets sold by KE. OZ Coupon Codes can be used only toward one-way or round-trip passenger tickets sold by OZ for flights originating in the United States and ending in the Republic of Korea, or originating in the Republic of Korea and ending in the United States.

- The Coupon Codes are valid for applicable flights taking place from June 27, 2016 through June 26, 2019.
- The Coupon Codes are redeemable only through kpacoupons.com.
- The Coupon Codes are freely transferable to others only through kpacoupons.com.
- The Coupon Codes are stackable. More than one Coupon Code can be used toward a rebate.
- Tickets for which the Coupon Codes may be redeemed are not subject to "black-out" dates.
- Coupons are not subject to a redemption or service charge of any kind.
- Coupon-eligible KE ticket numbers should start with "180." Coupon-eligible OZ ticket numbers should start with "988".
- For full terms and conditions regarding the redemption of coupons, go to kpacoupons.com.

Reimbursement Procedure: To receive your reimbursement after you have flown on an eligible OZ or KE flight, provide CCC with your ticket number(s) and corresponding Coupon Code(s). Once CCC confirms the validity of your Coupon Code(s) and ticket number(s), CCC will send a reimbursement check to you. Submit your ticket number, Coupon Codes and mailing address to CCC through the website, kpacoupons.com, or by mail or fax at the contact information below.

Sale or Transfer of Codes: If you wish to sell your Coupon Code(s) or buy more Coupon Code(s), CCC will facilitate a secondary market for the Coupon Codes throughout the redemption period. CCC will conduct an initial auction for the Coupon Codes. Further details on the auction are on the reverse of this page.

COUPON CODE AUCTION

Chicago Clearing Corporation (CCC) is the court-appointed administrator and market maker for the Coupon Codes issued in the litigation regarding Asiana Airlines and Korean Air Lines. It is CCC's role to facilitate the buying, selling and transferring of the Coupon Codes throughout the redemption period.

To kick off the market, CCC will conduct an initial auction (The Auction)—a two-sided auction that settles at a set time at one price. The Auction will take place on the website kpacoupons.com or by contacting CCC below to submit a bid to buy or offer to sell Coupon Codes.

The Auction will begin on July 11, 2016 and close at 5:00 p.m. Central Time on July 15, 2016.

In The Auction, Coupon Code holders may offer to sell their Coupon Code(s) at a certain percentage or higher of the face value of their Coupon Code(s). Interested Coupon Code buyers may bid to purchase Coupon Code(s) at a certain percentage or lower of the face value of the Coupon Code(s) they wish to buy. At the auction close time, (Match Time), CCC will match the largest face amount of Coupon Codes as possible at one price (Match Price).

The Auction is a dynamic process in which the prospective Match Price will change based on the incoming bids and offers. To help you decide what bid or offer you should enter to maximize your success, CCC will post the current Match Price at kpacoupons.com. The details of The Auction can be found at kpacoupons.com, where you can also track the market and submit your bids and offers.
